MINUTES OF A MEETING of Cradley Parish Council held in Storrige Village Hall on Tuesday 11th January 2011 at 7.30pm.

APOLOGIES for inability to attend the meeting were received from A. Eldridge and M. Brooksbank for business reasons and from P. Stanley for family reasons. C. Dawkins did not receive notice of the meeting and did not attend.

MINUTES – The minutes of the meetings held on 9th November 2010 and 17th November 2010 were amended then taken as read, confirmed and signed by the Chairman. It was noted that MA had not received notice of the meeting on the 17th November 2010 and had not attended.

PARISH PLAN REPORT – PD reported on three issues

- (1) He advised that a new head teacher had been appointed at Cradley School taking up Office in April 2011. His name is Adam Greaves, resident of the Village who he advised hoped to maintain strengthening relations between the School and the Community.
- (2) He advised that for legal reasons, the amalgamation of the administration service between Cradley and the Colwall Doctors would not now take place. Bruce Herriot is confident that Cradley Surgery would nonetheless be secure.
- (3) Following rumours that the local bus service is being curtailed, this matter had been handed over to the Transport Group for investigation.

AFFORDABLE HOUSING - Nothing further to report but copies of all correspondence had been sent to all Councillors.

PROGRESS REPORTS –

2011/02

Rectory Lane – Despite constant reminders from the Clerk no reply had been received to date concerning the status of this Lane.

A4103 – Nothing further to report regarding proposed speed restriction on this stretch of road but the Clerk was to request that old signage be taken down by the Vinesend following new signs being erected.

Drainage Issues – Report of meeting at Christmas Cottage had been copied to all Councillors. RG advised he had that day received some recommendations from Herefordshire Council which were to be copied to all Councillors with a further update at the February meeting. RG agreed to inspect the pipe exiting into the stream at Brookside to see if it was sewage, and if so, offered to deal with the matter.

ITEMS FOR CONSIDERATION –

Name of Development – RG advised unhappy with the proposed name of St., Katherine's Field and then left the room. CL proposed the Council look up the old field names map and ask the Heritage Group to come forward with an alternative name. This was seconded by KN and carried. Clerk to put our objections in writing immediately and advise that the PC would come forward with an alternative suggestion following our February meeting.

Offer of Assistance re Parish Plan by Mel Preedy – PD advised he had spoken with Mel Preedy thanking her for her interest and advising that the PC would get back to her in due course if this was felt necessary.

Problems due to Snow – Discussion took place regarding lack of salt in grit bins and people abandoning their cars on the main road. Article to be put in the Newsletter to this effect, but adding thanks for the efforts made at the recent funeral in the Village during the bad weather. SA agreed to obtain information regarding collection of a salt supply from Bromyard and if this was possible, he agreed to let TLJ know who would make enquiries of the Water Business at Mill Bank garage to see if they could offer any storage. Clerk to enquire of Herefordshire Council whether they could deliver two tons during the summer, and if so, the PC would look for a convenient storage point.

Donation to Cradley Village – (DCN, JE, CL & KN left the room) – RG took the Chair –

On a proposal by SA seconded by TLJ and carried, a donation to Cradley Village Hall in the sum of £2,480. was agreed. ***(DCN, JE, CL & KN rejoined the meeting).***

Elections – Local Elections will take place on 5th May 2011. Annual Meeting of the PC to take place on 11th May 2011. The Chairman advised that he would not be standing for re-election.

Parish Meeting – This will take place on Tuesday 19th April in Cradley Village Hall. Reports from usual groups plus speaker. PD proposed asking the new Head Teacher to be the Speaker. A budget of £50. was agreed for refreshments.

Planning – MA advised that consideration had been given to an application for relocation and increase in size of previously approved plant enclosure at Archers Mill to which no objections had been raised. He also reported on advices received from Herefordshire Council regarding applications approved, refused or withdrawn and that the Enforcement Officer had requested removal of the two caravans at The Old Hop Barn at Stiffords Bridge.

Playing Fields – The Chairman reported the Playing Fields Committ5ee members had drawn up a short list of various items of new equipment and landscaping proposals for the Chapel Lane site. These had been placed on a spreadsheet to facilitate interactive choices by children. No response had been received to this effort at consultation and KN agreed to put up local posters. RG agreed to check that the funds of £17,000. were still available from Herefordshire Council.

Editorial Group – KN advised website still being used on a regular basis and that the Reporter should be out within the next two weeks.

HALC – MA advised meeting on 19th January had been cancelled. HALC office is now being staffed full time so advice should be readily available.
